Medicine Wheel Ride – We Ride for Her

The Medicine Wheel Ride – **WE RIDE FOR HER** took place in during Arizona Bike Week on Friday, April 4th and Saturday, April 5th in Scottsdale, AZ.

On April 4th, Motorcycle Safety Lawyers® attended a program at the Talking Stick Resort addressing the epidemic of **Missing and Murdered Indigenous Relatives (MMIR) and Building Resilience**. This community event honored victims, raised awareness, offered resources, built skills for prevention, and helped foster solidarity in addressing the MMIR crisis.

The **Medicine Wheel Ride** took place at Harley Davidson of Scottsdale on April 5th where the group shared their mission and showed the documentary, **"We Ride for Her"**.

The MMIR crisis highlights the disproportionately high rates of missing and murdered Indigenous people in the USA. It's a national problem that impacts Indigenous communities. There are many movements and initiatives that work to raise awareness and advocate for policy changes. These efforts include grass-roots activism, community empowerment, and legislative action.



Missing and Murdered Indigenous Women (MMIW) mission statement is: We are Indigenous Women Motorcyclists and Allies who create awareness events and fundraise for issues affecting our Indigenous Woman and Relatives as well as issues in our Communities. We support groups and advocates who search for missing persons and provide support services to women and their families. These women come from multiple tribes across the United States and bring together their resources in support of their mission.

Motorcycle Safety Lawyers® supports the Medicine Wheel Ride, these wonderful women, and the work that they do. Did you know:

- Every 3 days a Native Woman goes missing in both the US and Canada.
- The murder rate for Native Women (girls+) is 10 times higher than all other ethnicities.
- Murder is the 3rd leading cause of death for Indigenous Women.
- Indigenous Woman face violence, murder & trafficking up to 10 times the national rate.
